Known Problems

The following problems have surfaced too late to be included in the Release Notes:

Xinerama

When Xinerama mode is enabled, StarOffice and FrameMaker applications generate core dumps if X server patch 108652-59 is installed on the Sun Ray server. An appropriate X Server or Sun Ray Server Software patch will be available soon.

Resolutions

`utsettings` and `utset` both show additional high resolutions, above 1280x1024. These resolutions have been built in to support future releases.

Multihead

In a multihead environment, moving the mouse too quickly when changing screens sometimes causes the cursor to jump to the edge of the first screen instead of going to the second screen; however, moving the mouse slowly does not cause this problem.

Bus Busy Icon

On some devices, the bus busy icon sometimes persists even after the transaction is completed, and keyboard and mouse events do not appear to be recognized. If the icon does not disappear after the job is done, the USB device should be unplugged then plugged in again.

Documentation Errata

Man Pages

The `utxlock` man page does not give the correct syntax for setting the `SUN_SUNRAY_UTXLOCK_PREF` property to use its own screen lock. The correct setting is:

```
SUN_SUNRAY_UTXLOCK_PREF="$HOME/bin/mylock -1";  
export SUN_SUNRAY_UTXLOCK_PREF
```

Removing SSL Certificates

Two sections dealing with this topic have somewhat contradictory instructions. Those in the section entitled “Removing the Software” on page 20 of the *Sun Ray Server Software 2.0 Installation and Configuration Guide* are correct. The online version of this manual has a cross-reference to this section from the section entitled “Disabling and Unconfiguring SSL Certificates” on page 55. Unfortunately, this correction was not included in the version of the manual found on the product CD.
